Definitions					
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include: Annuity Investors Life Insurance Company®, MassMutual Ascend Life Insurance Company, Manhattan National Life Insurance Company, MM Ascend Mortgage Lending, LLC, MM Vine Street, LLC, Counterpointe – Ascend Mortgage Lending, LLC, Massachusetts Mutual Life Insurance Company, C.M. Life Insurance Company, MML Bay State Life Insurance Company and MassMutual Trust Company.				
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. We only share your information with non-affiliates as described in this notice, and <i>not</i> so they can market to you.				
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. Firms with which we have joint marketing agreements with include insurance companies, pension funds and brokerage firms.

You may have additional rights under state or other applicable laws. We do not share information subject to the Fair Credit Report Act with our affiliates except as allowed by law.

You have a right to review the personal information in our files to determine if it is correct. To do so you must ask us in writing to the Privacy Officer at P.O. Box 5420, Cincinnati, Ohio 45201. Please include in the letter your full name, address, and account number. We may charge a fee for copies of records you request. If you believe the information is incorrect, please write to us and explain why you believe it is incorrect and we will review it. If we agree, we will correct our records. If we do not agree, you may submit in writing a short report of the dispute to our Privacy Officer.

**For Vermont Residents only:** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
